Getting Started

Complete Application: Complete the <u>Third Party</u> <u>Fundraising Application</u> a minimum of 15 days in advance of the scheduled event or activity.



Approval: Once approved, you'll be ready to start promoting your fundraising event!

Donations raised through these initiatives go directly to serving 33,000 tenants which include 9,000 children and youth in 155 OCH communities throughout Ottawa.

Guidelines

WE CAN PROVIDE:

- Support from staff via phone or email.
- Promotional support: share your event on our social media handles. Logo use (upon approval), brochures, flyers, and banners.
- Letter of acknowledgement for soliciting sponsors and donations.
- Create a personalize online fundraising page (optional crowdfunding).

Tax receipts (as per <u>CRA guidelines</u>). Please speak with OCH Foundation staff before offering to issue tax receipts.

Opportunity for OCH Foundation staff representative to be on site and speak at event.



- Be sure to thank your attendees, sponsors, donors and participants
- Submit your donation and any relevant tax receipt information within 45 days of your event
